## AGREEMENT FOR Senior Portraits, Modeling, or Freelance / Wedding Photography Event

1. ALL PHOTOGRAPHS and works created by Photography by Ronald, Ron's Custom Portraits, are Copyright Protected. It is a violation of federal copyright law to copy, scan or allow photographs we have created to be copied or scanned. The Client agrees to purchase photographs prints directly from Ron's Custom Portraits. The negatives/digital files will remain the sole property of Photography by Ronald, Ron's Custom Portraits. CD's may be provided to ease the ordering process.
2. LIMITS OF LIABILITY: The photographer will make every reasonable effort to produce and deliver your portraits. Photographer's entire liability to client for any and all claims is limited a) Retaking Photographs or B) a refund to client of the amount paid for services. We use digital film for professional photographers. Film upon request in advance. We do a lot to prevent problems, including scheduling sufficient time. We need everyone's cooperation in keeping to the time schedule. Insufficient time can have a direct impact on the quality of the portraits. If the client does not meet the time schedule, we will not accept any liability for missed portraits.
3. THE 50% RETAINER FOR PACKAGES IS NON-REFUNDABLE. Upon signature and receipt of the required RETAINER, the photographer will order the required package. The retainer WILL NOT be credited to a new sitting. If the package is canceled, the retainer will NOT be credited toward any products or services already performed, ordered or delivered. Any changes must be in writing. Remember; changes or cancellations on your part may cost us the loss of another booking that we could have signed.
4. PREVIEWS for viewing will be ready about 2-7 after the sitting date. All items purchased are picked up at Ron's Custom Portraits. No previews will be turned over to client until ALL outstanding amounts are paid. If someone else is to pick up albums or prints, we must receive that instruction from the signer.
5. PORTRAIT PRINT PRICING. Prices for additional portrait prints are agreed to and shown on the price list at Photorelect.com for customer who wish to order online 5-10 days. Orders for prints should be combined and placed within 5 days from when previews are ready. Print orders take about 10-15 business days. 3-5 clothing changes 12-15 poses
6. THE SITTING FEE AGREED TO IS \$ \_\_\_\_\_. This amount includes only the sitting. Previews/Consultations will be \$25 for the 1<sup>st</sup> hour if no prints are ordered this is our minimum charge.. The package chosen by the client may be upgraded to a larger selection any time before the order is placed. Prices for prints are subject to change according to market pricing.
7. Outstanding balance (if any)\$ \_\_\_\_\_ must be paid at time of preview presentation. A PAYMENT OF 100% of the package price is due at the time plus shipping and handling of ordering. I will not process your order until this is paid.
8. IF AFTER ONE YEAR FROM THE CLIENT'S SITTING DATE, the client has still NOT selected and ordered the album and prints that are included in their package, the client is subject to being invoiced at the current studio prices, with credit given toward amounts already invested.
9. This agreement and the investment amounts are subject to change if this agreement is not signed by both parties within 10 days of the below date.
